Meals and incidental expenses reimbursed must be ordinary and necessary to accomplish the official business purpose of the trip. There is no per diem for domestic travel less than 30 days. Travelers may seek reimbursement only for their actual expenses up to meal and incidental expenses cap of \$74. The cap shall not be treated as a per diem. Meal and incidental expenses reimbursement shall be limited to the actual reasonable costs incurred and is subject to a downward adjustment if meals are included as part of travel/registration.

For travel outside the continental United States (Hawaii, Alaska, etc.) and foreign travel, please refer to the per diem rates set forth by the <u>U.S. State Department</u>.
